Sub: Preponing of Summer Vacation

Pursuant to the order of the Minority Affairs & Madrasah Education Department, Government of West Bengal, vide No. 1108-MD/O/2M-06/2019 -MAME dated 18/04/2024 and in partial modification of the Addendum Notification issued by the West Bengal Board of Madrasah Education vide Memo No. 542/Aca/24 dated 04/04/2024, I am directed to inform all concerned that considering the prevailing heat wave situation, the summer vacation stands preponed with effect from 22.04.2024 (Monday) except for those madrasahs located in the hill of areas of Darjeeling & Kalimpong districts . The madrasahs of the hill areas of the Darjeeling & Kalimpong districts may continue existing academic schedule until further order.

The teaching and non teaching staff shall enjoy the leave as a special case during the period or till the madrasahs reopen, subject to the directions issued by concerned Election Authorities in view of ensuing Parliament General Elections 2024, and /or when required for fulfillment of activities and responsibilities for execution of various students welfare programmes of the Government of West Bengal and/ or for any special direction issued by Minority Affairs & Madrasah Education Department, Govt. of West Bengal and /or West Bengal Board of Madrasah Education.

The teaching & non teaching staff of madrasahs shall make suitable arrangements for conducting extra classes after reopening of madrasahs to make up the academic loss due to proponent of summer vacation as stated above in the interest of the students.

All Heads of the Madrasahs are requested to comply with the above mentioned order accordingly.
